  PAETC.
- o BoS just approved DHSP, DMH, DPH merging into a single agency. Los Angeles County is an anomaly in having a standalone Department of mental health LAC has the biggest administrative direct service provider agency in the world. Health reform has made integration discussions come forward and inevitable Mitch Katz will head this up. DPH and DMH were not involed in the preliminary discussion for the consolidating of these three agencies. This came from DHS. In general, this can be seen as the one stop shop like the "the Walmart of Care". NAMI was one of the advocates for consumers who are wary of this merger due to historical references where DMH was under DHS and mental health care didn't do well. There was an amendment to this merger is that stakeholder groups and DMH and the Sheriffs Dept will be involved at all levels in the process of this merger. (Watch the meeting minutes **KLCS** tonight at 10:30pm). Dr. Fielding was respectful of the idea, but he is opposed to it. All the departments are theoretically going to stand, but it remains to be seen how that will play out.
