### • Public Comment & Discussion

- Elyse is leaving APLA in March. She is going into private practice. The new HOPWA-funded therapist contract will start in April. Email Brett or Elyse. Must at least have BBS number – must be able to work with homeless populations.
- Still no word on HOPWA grants. APLA has been looking for alternative housing sources in the interim. Theoretically in April when the new contract begins the HOPWA funds for all of LA County will be released.
- Good Sam is laying off 45 people (closing oncology floor). The silver lining is that oncology is moving toward outpatient services (people stay healthier). There is a whole new building for doctor's offices.
- There was a protest about the closing of Thaliens at Cedars-Sinai, but no one knows how the protest (organized by NAMI) went.
- DMH is "aggressively" looking for psychiatrists. They want to lower the waiting list (depending on the clinic - going into April at this point)
- On 01/18 DMH met at "OAPP" Carlos, Jennifer Sayles, Angela Boger, David Whitehead, Renee (DMH Liaison), DHS, AltaMed, APLA, AHF (?), ASC represented- Tom wants the minutes
- Issues with billing (licenses) ie: assessment. DHSP wants everyone who provides services to be registered with BBS. Social workers are nationalized. MFT not. In the context of healthcare reform there are a lot of considerations.
- Re: SUD none of the healthcare reform language includes SUD. Sherry Larkins, Tom Freese etc. (ISAP folks) would probably be good to know.
- What the &\*\$% is "LA Care"? DMH clients have to be in LA Care (as opposed to HealthNet).
   All health clinics & physicians are LA Care. Many have both Healthnet and LA Care. DMH services are all under LA Care.
- o International AIDS Conference in Washington DC coming up.
